Our department offers three BA concentrations in Economics: Major, Specialization, and Honours. All three share a common core: Stage I, then ECON 301, 302, 303, 304.

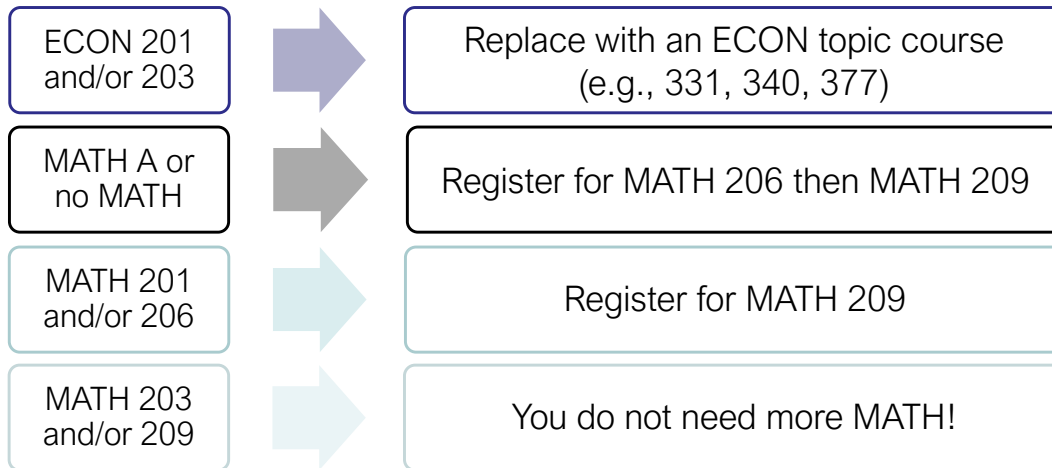
- Honours: 60 credits, recommended for students interested in graduate studies, possible to apply via internal process
- Specialization: 60 credits, a lot of flexibility in advanced (400-level) ECON course selection
- Major: 42 credits, the basics and a taste of advanced courses. Leaves a lot of space for non-ECON credits, so easier to pair with another Major or a Minor.
- Our BA programs are like building blocks: once you have completed all prerequisites for a specific course, you can take that course, e.g., ECON 201 + 203 = access to ECON 318 and 319.
- Students are free to progress at their own rhythm by following the prerequisite structure. Because of that, we do not provide an annual schedule.
- The Undergraduate Calendar shows a full description of courses, including their prerequisites:

- To see which courses are offered in the current academic year, please consult the Concordia Class Schedule via your Student Centre. You can search by semester (/1 = Summer, /2 = Fall, /3 = Fall/Winter, 4 = Winter), by level (200, 300, 400), by time, etc.
- It is possible to switch from one concentration to the next (e.g., Major to Specialization or Honours) once requirements are met. For more information, contact Melissa Faisal at [melissa.faisal@concordia.ca](mailto:melissa.faisal@concordia.ca).

# ECON & MATH exemptions

An exemption does not grant you credit and blocks you from taking the exempted course at Concordia. If you received an exemption for:

Exemptions (EX) and potential exemptions (PEX) appear on your offer of admission and on your unofficial transcript.

- The most commonly seen exemptions for Economics students are ECON 201, 203; MATH 201, 203, 206, and 209.
- The exemptions that you might receive depend on your previous studies, either in cégep or in another university. Many of our students do not receive exemptions: that's ok! Not having exemptions will not affect the duration of your studies, but you will need to use some of your open elective credits for the MATH courses.
- The decision on exemptions is made by the Admissions Officer named in your offer of admission: their name, phone number, & email address are on the second page of your offer of admission under the **Admissions Contact** heading.
- Potential exemptions (PEX) will be reviewed again prior to the start of term: if you have any PEX, verify your student record to ensure that these exemptions were changed to an EX. If not, then it means that the exemption was not awarded.
- MATH 201 = MATH 206; MATH 203 = MATH 209.

- MATH 201 and 203 are designed for Science and Engineering students, while MATH 206 and 209 are for Economics and Business students. You don't need all four courses for Economics, only two: MATH 201+203 or MATH 206+209.
- Students exempt from MATH 201 and/or 203 do not need more math.
- Students considering a Minor in a science or computer science department should consider the MATH 201+MATH 203 stream instead of MATH 206+MATH 209.
- MATH courses will count towards the 6-credit General Education degree requirement, as the Department of Mathematics and Statistics is in the Science sector.
- Some students may want to take a course even if they have an exemption for it. You need to fill out a form acknowledging that you will not retain credit for the course: please contact Melissa Faisal at [melissa.faisal@concordia.ca](mailto:melissa.faisal@concordia.ca) for more information. The grade for the course will not count in your cumulative GPA but will count in your current term and annual GPA.

You must think about your goals and personal situation as they may affect your registration choices. It is your responsibility as a student to register for your courses. We do not save seats for students or enrol you in any classes, even mandatory ones.

- Our advising team cannot guide you about other departments' courses or programs. You must go to the department or school that offers the program you're interested in for information about transferring (for example, go to Math & stats for MATH, JMSB for COMM, GCS for Computer Science or Engineering, etc.).

# Statistics courses equivalencies

## ECON 221 Statistical Methods I (3 credits)

Prerequisite: Cegep Mathematics 311 or MATH 201 or 206.

*NOTE: Students who have received credits for BIOL 322, COMM 214 or 215, DESC 244, ENGR 371, GEOG 362, MAST 221 or 333, PSYC 315 or 316, SOCI 212 and 213, or STAT 249 or 250 may not take this course for credit.*

*NOTE: Students in the Major in Economics are required to take ECON 221. Credits earned for SOCI 212 or INTE 296 will not be counted towards the degree.*

## ECON 222 Statistical Methods II (3 credits)

Prerequisite: ECON 221; MATH 203 or 209; or equivalent.

*NOTE: Students who have received credit for MAST 333, PSYC 316 or STAT 250, or for any combination of MAST 221 and 333, PSYC 315 and 316, or STAT 249 and 250, may not take this course for credit.*

- You can earn MAX = 6 such statistics credits.
- Economics students should take ECON 221 and ECON 222.

**When in doubt, ask an Economics Academic Advisor!**



Because different departments offer statistics courses, ECON 221 and 222 list some equivalencies: this is done so students won't lose credit if they already took equivalent content (see the note in yellow in the slide)

Each department has their own approach. For example:

- Department of Economics: COMM 214 or 215 = ECON 221
- JMSB: ECON 221 + 222 = COMM 214 or 215

The Department of Economics is housed in a different Faculty (Arts & Science) than JMSB. Since JMSB makes all decisions regarding transfer to its programs, our department staff and advisors cannot advise you on the internal transfer to any of the BComm programs.

- Students preparing for a transfer are not required to follow the BA Economics academic requirements, unless the destination program asks for ECON classes.

# The course registration golden rules

1. Adding and dropping classes is your responsibility
2. Register for the entire academic year
3. An 'Open' class may not be available to you
4. Trust the system, but verify
5. Give yourself time to figure things out...and remember that we are here to help you



## 1. Adding and dropping classes is your responsibility

- The department will not add or drop courses for you, nor will it save you a seat in a mandatory class.
- The more you wait before registering, the less chance you have of getting your first pick of classes.
- To be considered as a full-time student, you need at least 12 credits in the Fall, and the same in the Winter. Consider the number of credits when building your schedule, not of classes!

## 2. Register for the entire academic year

- The more you wait, the harder it will be to find open classes.
- Each spring, you will see your 'Enrolment dates' in your Student Centre: this is the date on which you will be allowed to register for Summer, Fall, and Winter classes

for that academic year.

### 3. An 'open' class may not be available to you

- Each department sets aside a certain number of seats for their program students: sometimes, 100% of seats in a class are reserved for program students!
- Even if your goal is to transfer, your desired program's courses may be closed to you until you officially transfer (e.g., most COMM courses are closed to non-BComm students, or most Fine Arts classes for non-BFA students).
- If you attempt to register for an 'open' class and the system immediately puts you on the waitlist, that's a hint that this course is not open for you.
- Don't linger on that waitlist: choose something else. You can use the SWAP feature in case the unit offering the course makes seats available for non-program students.
- Elective classes are courses that each department makes available for non-program students. This list can be helpful when looking for electives:

### 4. Trust the system, but verify

- After adding or dropping a class, check your Student Centre to make sure that the change has been made.
- The system will let you register both for the first course in sequence and the next in sequence: it trusts that you will pass the first class.
- If you fail a class, the system will not deregister you automatically if you already registered for the next class in the sequence. You must drop the class yourself and choose something else.
- Students are allowed to repeat a class once, unless they already completed the next course

in sequence.

- Skipping program requirements is not an option, unless you received transfer credits.

## 5. Give yourself time to figure things out...and remember that we are here to help you

Concordia's system and rules may be very different than what you are used to! This is why we encourage you to be engaged and involved throughout your studies. There are lots of resources and people available to assist you in understanding the rules and how the system works.

**Remember! The Economics advising team can only speak to Economics course selection and progress in the BA Economics.** Questions about transferring to another program, including eligibility requirements and course selection pending the transfer, should be addressed to the department or school that offers the program you are interested in.

- Newly admitted students must attend a full Touchstone Economics session before getting access to one-on-one advising appointments.
- When in doubt about your Economics course selection, or if you have questions about graduate studies or career paths...book an appointment or attend a drop-in session with the undergraduate Economics advisor.
- You can also write to [econ.advising@concordia.ca](mailto:econ.advising@concordia.ca) or call 514-848-2424 x3900.
- There is no limit to the number of times a student can meet with the Economics advisor. Advising appointments are capped at 15 minutes to accommodate the volume of requests.
- An advisor cannot add or drop classes for you.

### Before meeting for advising

- Prepare your question(s)
- Have your course schedule and your [unofficial student transcript](#) ready
- Be ready to take notes!

## Your next steps

- ▶ **Wait for the removal of the advisor hold by the department (within 24 to 48 hours)**
- ▶ Register for your courses as soon as you can: Fall admits should register for their Fall and Winter courses. Your admission will be revoked if you do not register for the semester you were admitted to.
- ▶ Get your student ID card in LB-115 (must wait 24 hours after enrolling in courses).
- ▶ Pay attention to the Academic Dates and Deadlines (CU account):
  - DNE (Did Not Enter) withdrawal has **no academic and no financial impact** on the student.
  - DISC (Discontinued) withdrawal has a **financial impact** on the student.

- The « Must See an Advisor » registration hold has to be manually removed by the department before you can access course registration.
- You can use the add courses to your course cart before the hold is removed; however, you will not be able to complete your registration before your enrolment appointment date and until the hold is removed.

- Getting your Student ID card (LB-115, 1400 De Maisonneuve W). A student ID card lets you borrow items from the Library, use on-campus printers, take the Concordia Shuttle bus between downtown and Loyola, and more.
- It is your responsibility to register on time, and to keep track of the DNE and DISC deadlines! The deadlines change every semester, so reviewing them each year is essential.
