In Memoriam



It is with heavy hearts that we heard the shocking news of Elaine Carsley's passing at the end of January. She obtained her MPPPA in 2004 from Concordia University and enrolled in a PhD program at Carleton. She taught part-time in the department from 2007 to 2010 and then again from 2019 to 2022.



On May 22, 2023 we were again very sad to find out that Dr. Horst Hutter had passed away, after a long illness. He was 85 years old. Horst joined the Department of Political Science at Sir George Williams University in the early 1970s, before the merger with Loyola College that would lead to the creation of Concordia University in 1974. He was held in high esteem by all his students and taught with us well into his seventies. A specialist of political theory and the history of political thought, he was well known for his acclaimed scholarship on 19th century German philosopher Friedrich Nietzsche. He is the author of Shaping the Future: Nietzsche's New Regime of the Soul and Ascetic Practices (Lexington Books, 2005) and co-editor (with Eli Friedland) of Nietzsche's Therapeutic

Teaching for Individuals and Culture (Bloomsbury, 2013).

The faculty, staff and students of the Department of Political Science extend their sincerest condolences to Horst's wife Francine Prévost-Hutter and their sons, Harald and Florian.

Kudos

Professors Mireille Paquet and Antoine Bilodeau are among the research leaders who were recently awarded a \$98.6 million grant from the Canada First Research Excellence Fund (CFREF) to study migrant integration during a time of rapid technological transformation. Entitled "Migrant Integration in the Mid-21st Century: Bridging Divides," the project brings together researchers from Concordia, Toronto Metropolitan University, the University of Alberta, and The University of British Columbia. It will include 25 research leaders, more than 100 scholars, and it will offer 1,500 training opportunities and involve more than 200 organizations.



Professor Marier is part of a team of economists who received a FRQSC Team grant Étude des conditions de vie et des systèmes publics et privés de protection sociale liés au vieillissement de la population québécoise. \$318 707. 2023-27.

Francesca Scala is part of a team that was awarded a \$250,000 grant from the Government of Canada's New Frontiers in Research Fund (NFRF) – Exploration stream to investigate how point-of-care ultrasound and artificial intelligence (AI) can improve access to care for breast cancer-related lymphedema. The team is led by Dr. Hassan Rivaz (PI) in Electrical and Computer Engineering and includes Robert Kilgour, professor in the Department of Health, Kinesiology and Applied Physiology and Anna Towers, associate professor of oncology and family medicine at McGill University.





The MPPA Program's Case Competition Team won Bronze at the Annual CAPPA Case Competition. The star team consisted of Lucas Driediger, Kami Elmekki, George Frank (alternate), Samuel Jetté, and Amanda Loukatos. The case examined was whether Canada should adopt a Central Bank Digital Currency ("Preparing for the Future: Modernizing Transaction Through a Central Bank Digital Currency").
