12. Reports from the Associate Deans

12.1 A. Bakr Ibrahim, Associate Dean, Masters and Graduate Diploma Programs (JMSB-2012-05A-10)

Associate Dean Ibrahim presented the report. He explained that even though the numbers for Fall appear to have declines, the Winter numbers are healthy. However, it should be noted that most universities are seeing a decline in enrollment due to the economic situation. This said the recruitment strategies have intensified this year. As well, the MBA area is reviewing curriculum. This will be accomplished after the Assurance of Learning (AOL) exercise is completed this year.

There is a decline in the CA/CMA area due to the change to the program. It will become the CPA as of 2015. This will require dramatic changes in the present curriculum to ensure the program is in line with Bill 61 (the amalgamation of all accounting designations).

Associate Dean Ibrahim mentioned that his team has been a great support to him and he thanked them for all of their work.

Dean Harvey thanked Associate Dean Ibrahim for the reports and the efforts of his team.

13. Presentation: Mobile and Hybrid Course Evaluation Pilots (JMSB-2012-06A-02)

Vice-Provost Dyens gave a brief presentation on the Mobile and Hybrid Course Evaluation Pilots. It was suggested that, as the response rate has not been as strong with online course evaluations as it was with paper, it was suggested that the Office of Institutional Relations undertake a survey to determine the reasons behind the lower response rate.

As a result, there will be Mobile and Hybrid Course Evaluation pilots. The mobile option will allow students to complete the evaluations on their mobile device. The pilot will be conducted in the Faculty of Arts and Science (Political Science).
