- P. Sicotte mentioned the following points:
 - The Provincial budget was announced and there is no new monies for Universities; but there is a re-shuffling of existing money in different envelopes;
 - Applications and admissions are not as low as expected however the good work needs to keep going to increase the number of registrations. Units are commended on their good work so far;
 - Concordia's NSERC success rate was above the national average, SSHRC was a bit lower. FAS' application rates were equivalent to pre-pandemic rates. Grants are an excellent tool to attract and retrain graduate students. Thank you to everyone applied;
 - Convocation will be on June 4th at Place des Arts;
 - Current hires (TT, CRC, LTA, ETA) are progressing;
 - There will be no calls for TT positions this year however, exceptional opportunities might be considered;
 - FAS is considering have Faculty Council meetings only downtown on Fridays and All Chair meetings will be only at Loyola on Thursdays.

Topics such as possibility of adding new sections due to higher than anticipated enrolment, waiting lists, reserve courses, alternative scheduling, needs of students, facilities issues, tuition fee calculator and tuition amounts were discussed.
