Roles and Responsibilities in the Exchange Program

Concordia International:

Your first point of contact for non-academic issues. Concordia International is responsible for:

- Managing non-academic issues related to the exchange program
- Administering the Quebec Mobility Bursary
- Handling exchange coding and other related processes
- Overseeing the receipt and processing of official transcripts from your host institution
- Correspondence with the host institution on matters such as:
- Medical & travel insurance advisement
- Legal issues
- Emergency contact information
- Your Faculty:

Responsible for all academic-related matters, including:

- Approving courses and assisting with transfer of credits
- Waiving pre-requisites, if applicable
- Providing registration assistance post-exchange
- Supporting potential graduates with academic advising

Your Responsibilities:

As a student, you are responsible for:

 Meeting all academic and non-academic requirements at both Concordia and your host institution

BEFORE LEAVING CONCORDIA

ACADEMIC PROCEDURES

Admission Letter Timeline:

You will receive your admission letter two months after the host application deadline.

• Final Admission Decision:

HOST ADMISSION PROCESS AND RESPONSIBILITIES

Your host university makes the final decision regarding your admission and the availability of courses.

Ensure that your International Liaison Officer (ILO) has a copy of your admission letter. • Submission of Admission Letter:

• Meeting Deadlines:

It is your responsibility to ensure that you meet all deadlines set by your host university.

Registration at Concordia during your Exchange Semester

Course Registration:	Register for courses at Concordia for the semester you plan to be on exchange
STOQ Coding	All exchange students will receive a course placeholder code : STOQ (Studies Outside Quebec)
STOQ credits	Undergraduate Students : STOQ=15 Concordia credits (equivalent to full-time tuition) Graduate Students : STOQ = Full-time Status
STOQ Code Activation	The STOQ code will be added closer to your departure after completing the pre-departure requirements and receiving the host admission letter
Importance of Maintaining Full-Time Status	The STOQ code ensures you remain a full-time student at a Quebec university. STOQ Code doesn't ensure that you are registered full-time at your host university. IMPORTANT: Do not drop this coding in your MyConcordia portal.

Dropping Concordia courses prior to DNE

You are responsible for dropping all Concordia courses you have enrolled in for the exchange semester by the DNE deadline.

Warning: Failure to drop the courses means you will be charged for both the STOQ credits and the Concordia courses.

Registration at Host University

Course Availability:	Host institutions cannot guarantee enrollment in desired courses Flexibility in course selection is required
Course Approval	Only take courses that have been approved in writing by your department or faculty advisor
Credit Requirements	Verify with your faculty the number of courses/credits needed to meet Concordia's minimum full- time registration requirement. Minimum Equivalent: 12 Concordia credits Maximum Equivalent: 15 Concordia credits Graduate Students: Must maintain a full-time course load
Variation in Course Requirements	The number of courses required to meet Concordia's minimum/maximum full-time course load will vary by institution. Each host institution has its own registration system.
Grading Policy	Courses graded with pass/fail (P=Pass or F=Fail) will not be credited towards your degree.

BEFORE LEAVING CONCORDIA

Travel Preparation

IMPORTANT TRAVEL & VISA INFORMATION

Passport Validity: Ensure your passport is valid for at least **6 months** beyond your return date.

Student Visa Requirements:

- A **host university admission letter** is required to apply for a student visa.
- Check your host country's **immigration office website** for specific student visa requirements.

Purpose of Travel:

• Your primary reason for going abroad is to **study, not work**. Be mindful of visa restrictions regarding employment.

Dual Citizenship Considerations:

• Investigate whether your **dual citizenship status** could affect your visa application or travel plans.

ACCOMMODATIONS



On-Campus Housing:

•Not all institutions offer on-campus housing.

•If available, **apply early** to secure a spot.

Off-Campus Housing:

- If on-campus housing is unavailable, you will need to **arrange independent accommodations**.
- Be aware of potential challenges in finding housing—**start your research early**.
- Watch out for scams when searching for accommodations.

Adjusting to New Living Standards:

•Housing abroad may differ from what you're used to at home.

•Do thorough research and be prepared to **adapt** to different living conditions.

BOOKINGYOUR FLIGHT

Do not book any flight until you have received your official admission notice from your host university

You are financially responsible for all travel costs to and from your host destination

You may want to purchase a travel insurance package to cover

Flight cancellationTrip interruptionBaggage/personal belongings

You can apply for travel funding via LOJIQ if you are a permanent Quebec resident. Information regarding their application process has been sent to all CSEP participants



Health Insurance Requirements:

Ensure you meet the health insurance requirements of your **host university** and **country**.



Concordia Health Insurance:

Some students may be able to use their **Concordia health insurance coverage** while abroad.

For details, consult the **Studentcare** website.

Additional Insurance Considerations:

Consider the following types of insurance: •Emergency and medical evacuation •Repatriation insurance •Travel cancellation insurance •Property insurance •Liability insurance

Mandatory Health Insurance:

Be aware that your host institution or country may require you to purchase their **health insurance coverage**.

HEALTH INSURANCE COVERAGE



Quebec Health Insurance (RAMQ) coverage

Notification Requirements:

•If you have **RAMQ coverage**, you must contact RAMQ to notify them of the dates you will be studying abroad.

•Failure to do so may result in your public health coverage expiring if you are away for more than **183 days**. Note that the days spent on exchange will count toward this limit.

Coverage for Students Abroad:

Students who inform RAMQ that they will be studying abroad.

•Will remain covered for the entire duration of their studies as if they were still in Canada.

•Will have the **183-day countdown** start only after the exchange semester ends, provided they remain outside Canada.

Required Documentation:

•To maintain coverage, students must complete a specific form, which is mailed by RAMQ to their home address in Quebec. This form is **not available online**.

HEALTH AND WELNESS WHILE ABROAD



Research Destination: Understand local healthcare systems and wellness resources.



Medical Exams:

Ensure you have taken necessary medical, dental and eye examinations prior to departure.

Concordia health clinic provides medical exams and some vaccinations for students travelling abroad.

Medication Management:

Pack necessary medications with a doctor's note; know local pharmacy options.

Make sure any medication you need to take is legal in your destination country.

Pack a First Aid Kit and wear Medic Bracelet if needed.

Vaccinations:



Make certain to get all immunizations required by your host country or any country that you may be travelling to while on exchange.



IMPORTANT DOCUMENTS TO COPY

Make copies of important documents:

- Passport
- Admission letter
- Prescriptions
- Medical records
- Keep a set in Canada and take a set with you

AUTHENTICATOR APP (MFA SIGN-IN)

Install <u>Microsoft Authenticator app</u>:

- Ensures access to your Concordia account while abroad
- Replaces text message which might not work abroad
- Visit <u>https://aka.ms/mfasetup</u> using an incognito/private browsing
- If you are student, please sign in with your <u>netname@live.concordia.ca</u> email address. The password is the same password you use to login to concordia.ca
- From there click on the "Change" button at the top of the page to input a new authentication method



WITHDRAWING FROM THE PROGRAM

Common reasons for withdrawing from exchange

- •Lack of adequate financial resources
- •Death or illness in the family
- •Inability to find adequate number transferable equivalent courses
- •Other academic or work commitments

Steps to take when you withdraw from exchange

- Please inform your Concordia International ILO IN WRITING as soon as you know that you will withdraw from the program
- Make certain that if you have already been STOQ coded, that the code is removed from your transcript
- If you withdraw after DNE deadline / during your exchange semester, you will be responsible for the tuition fees that the STOQ has charged you
- Your bursary application will not be processed or if you have already begun your exchange and withdraw while on exchange, you may be required to reimburse the bursary

ARRIVING AT YOUR HOST UNIVERSITY

Settling in and studying abroad

COMPLETING & SUBMITTING THE CONFIRMATION OF ARRIVAL

Complete and return the Confirmation of Arrival form to Concordia International MAXIMUM two weeks after your course registration is finalized at your host institution

Take this form to your host institution's International/Exchange office for a signature and/or stamp confirming that you are enrolled at that university

Return this form to Concordia International by e-mail (international@concordia.ca)

Not returning this form could result in having your exchange status at Concordia cancelled

Cultural Awareness

Opportunity for Growth: Studying abroad offers a unique chance to develop professional, language, and intercultural skills. Cultural Differences Matter: Even in countries that seem geographically or culturally similar (like within Europe), cultural differences should not be underestimated. Immersive Learning: Unlike a short holiday, living abroad provides an opportunity to immerse yourself in a new environment, allowing for a deeper understanding of that country's culture. Challenges of Cultural Understanding: You may encounter situations where cultural misunderstandings arise due to aspects of the culture that are not immediately apparent.

EXAMPLES OF CULTURAL DIFFERENCES IN THE CLASSROOM





Eating in Class: Considered impolite and strongly discouraged.

Avoid wearing sweatpants, flip-flops, or
pajamas to class.
Many partner institutions expect students to
dress formally and conservatively.Email Etiquette:Avoid sending "one-liner" emails.
Always begin with a proper greeting and
address the recipient by name.
Include your full name, host institution
student ID number (if applicable), and
mention that you are an exchange student.

Punctuality:

Arriving late to class is widely regarded as disrespectful.



Attendance:

Regular attendance is crucial; missing more than **two classes** without a medical note may lead to a failing grade at certain partner institutions.

CULTURAL DIFFERENCES



- Communication styles and rules:
 - Public displays of affection: in many countries PDA is frowned upon and considered offensive
 - Body Language: Slouching in your chair, sitting with your arms crossed, or yawning in class may be considered disrespectful
 - Expecting the same "student-friendly" service offered by Concordia University at your host institution's internal offices/departments
- Concepts of time:
 - Waiting for a response from administrative at your host bodies may be longer than what you are used to at Concordia
- Attitudes toward authority:
 - Confronting authority figures or professors regarding grading, assignments etc. may not be perceived in the same manner as it would be at Concordia

MANAGING YOUR EXPECTATIONS

You may find that your personal expectations of the country, its people, the institution, etc. do not match reality

Identify the reasons you wish to study abroad

What are your impressions of the country where you will be living? Are they realistic?

Research your host country as much as you can in advance

Learn the laws and customs

Expectation	Reality				
Exciting New Culture	Culture shock can be overwhelming; adjustments take time				
Fluent Language Skills	Language barriers may persist, and communication can be challenging.				
Easy Social Integration	Making friends can be difficult, and building relationships takes effort.				
Beautiful Living Conditions	Accommodation may not always meet expectations; it can be basic or shared.				
Travel Opportunities	Travel can be expensive and time-consuming; schedules may be restrictive.				
Learning Opportunities	Learning can be challenging due to different teaching styles and expectations.				
Personal Growth and Independence	While independence grows, feelings of loneliness and homesickness can also increase.				
Cultural Exchange	Misunderstandings can happen, and navigating cultural differences requires sensitivity.				
Networking and Career Opportunities	Building a professional network takes time and may not yield immediate benefits.				
Unique Extracurricular Activities	Opportunities may be limited or different than expected; involvement takes effort.				
Support from Fellow Exchange Students	Not all exchange students will bond; some may feel isolated in their experiences.				

Conclusion

Exchange students should prepare for both the highs and lows of their experience. Being open-minded and adaptable can help them navigate the differences between their expectations and reality.

MENTAL HEALTH WHILE ON EXCHANGE

Tips for Maintaining Your Wellbeing

- 1. Keep an Open Mind Embrace new experiences and perspectives.
- 2. Attend Orientation and Welcome Activities Engage with the university community from the start.
- 3. Join Student Groups Connect with others who share similar interests and experiences.
- 4. Develop Patterns and Routines Establishing a daily routine can provide stability.
- 5. Explore Your Surroundings Take time to discover your new environment and local culture.
- 6. Set and Achieve Small Goals Focus on attainable objectives to build confidence and motivation.

7. Focus on Language Acquisition Improving your language skills can enhance your experience and communication.

8. Exercise Regularly

Physical activity can reduce stress and improve overall mental health.



TRANSCRIPT & TRANSFER CREDITS

Credit transfer is requested by Concordia International upon receipt of your official host university transcript

Your faculty transfers your credits – can take up to 3 months

Only courses that have been pre-approved will get transferred

Eligibility for Refund:

Undergraduates who register for and successfully complete the equivalent of **12** previously approved credits will be refunded the **3-** credit difference.

Refunds will be issued once credits have been transferred by faculty after the exchange.

Refund requests are submitted by **Concordia** International.

Processed by the Student Accounts Office.

Conditions for No Refund: You will **not** receive a credit refund if any of the following conditions apply:

You registered for **less than 12 Concordia credits**. You registered for the **equivalent of 15 Concordia credits**.
