Re: Fund Balance Availability Check(FBAC)-Update

In the summer 2024 the fund balance availability check(FBAC) was turned on in Unity for all research Tri Agency grants.

Research & Restricted Financial Management - Concordia University

This system functionality serves the research community with a tool to prevent overspending on grants. Below is an example of an error message that will appear when a transaction fails due to insufficient funds in Unity is:
