

# John Molson MBA GMAT Waiver Request Form

Applicants who completed an eligible university degree in Canada may request a GMAT waiver, which requires completion of the self-assessment checklist to determine whether they meet the minimum criteria.

Please refrain from submitting a GMAT waiver request if you do not meet the minimum criteria.

#### Instructions:

Please enter the information requested in the below form.

Applicants need to submit an attachment to their application file entitled "GMAT waiver request". As a single document, applicants need to include the self-assessment form and if they meet criteria 7 or 8, they must also include copies of the professional designation or certificates as part of the attachment.

- I. In the application portal, go the attachments section;
- 2. Select the document type drop down list;
- 3. Choose "Note from Student";
- 4. Add as the custom description "GMAT Waiver Request"
- 5. Select "add attachment" or "upload file" (depending where you are in the application process);
- 6. Attach the GMAT Waiver Request file.

#### Notes:

- 1. Simply meeting the minimum criteria for a GMAT waiver is not a guarantee that the request will be granted. Each request will be reviewed in a holistic fashion.
- 2. If a GMAT waiver request is not granted, the applicant will be required to submit the GMAT to meet the admission requirements.
- 3. Concordia uses a GPA scale of 4.3
- 4. Applicants should know that certain industries (e.g., Consulting and Finance) may ask a GMAT score as part of their hiring requirements. Therefore, it may be in the best interest of the applicant to undertake the GMAT.

To be considered for a GMAT Waiver, you must meet one (or more) of the below criteria. Please check off all those that apply. As previously mentioned, you must have completed an **eligible university degree in Canada.** 

**Criterion I**: Completed an undergraduate degree with a minimum cumulative GPA of 3.3 (B+) in Business (including Economics) or STEM.

**Criterion 2**: Completed an undergraduate degree with a minimum cumulative GPA of 3.7 (A-) in other majors that includes at least one quantitative course passed with a GPA of 3.0 (B)or better.

**Criterion 3:** Completed a Master's degree with a minimum cumulative GPA of 3.3 (B +) in any field that includes at least one quantitative course passed with a GPA of 3.0 (B) or better.

**Criterion 4:** Completed a PhD degree in any field that includes at least one quantitative course passed with a GPA of 3.0 (B) or better.

**Criterion 5:** Completed the John Molson Graduate Diploma in CPA program, with a minimum cumulative GPA of 3.3 (B+).

**Criterion 6:** Completed the John Molson Graduate Diploma in Business Administration, with a minimum cumulative GPA of 3.3 (B+), and passed the Business Data Analytics course (GDBA530) with a GPA of 3.0 (B) or better.

**Criterion 7:** Passed the Common Final Exam (CFE in Canada, or former UFE) for a Chartered Professional Accountant (CPA) designation, or at least the Level II examination of the Chartered Financial Analyst (CFA).

**Criterion 8:** Obtained one of the following professional designations: Canadian P.Eng. (Professional Engineer), PRM (Professional Risk Manager designation, PRMIA), FRM (Financial Risk Manager, GARP), or FCIA (Fellow of Canadian Institute of Actuaries).
