Summary: A monograph under preparation that starts off by laying down a broad and holistic conceptual vison of 'human development'. Summary: This monograph undertakes a comprehensive view of the long-term growth prospect of Bangladesh in the South Asian perspective. A set of regulatory and supervisory directives are then put forward that promotes product and process innovations safeguarding the goals of cost efficiency, financial viability and client inclusivity.]

(5) Jurisdictional Representation in a Federation: A Proposal and Illustrations from Recent Canadian and US Elections (CESifo Working Paper # 8676, U Munich, Germany)

This research proposes a novel idea of jurisdictional-level proportionality specifically targeted at federal systems. Emphasizing the primacy of jurisdictions (namely provinces and states) within a federation, we use data on the voting pattern in each such jurisdiction to determine the allocation of elected delegates (or electoral seats for that matter) that would be utilized in the eventual makeup of the ruling government. Our design ensures that the mechanism encompass the governance virtues such as (a) inclusivity and stability of the elected government, (b) accountability of elected delegates and their interface with voters, and (c) and fully conform to the principle of proportionality.

VIII. International Development Experience

1. **January 2009-2013**: Institute of Microfinance, Dhaka, Bangladesh. Leading a longitudinal study, "**Microinsurance, Poverty & Vulnerability**" (www.inm.org.bd).

Activities performed: As the Team Leader of Microinsurance at the Institute of Microfinance in Dhaka Bangladesh during 2009-13, among other, I have recruited, nurtured, and motivated a team of about 15-18 researchers field staff and led them to undertake a longitudinal study of microinsurance in the BDG context. The latter task involved designing a micro health insurance scheme. The latter is currently being piloted by a commercial insurer (GDIC) in a rural location in collaboration with a private Medical College Hospital in Mymensingh, Bangladesh (CBMCH).

2. June 2011-March 2012: PKSF/ADB/JFRPR.

Team Leader 'Developing Inclusive Insurance Sector project (DIISP)' undertaken by PKSF and funded by Japan Fund for Poverty Reduction (JFPR) and administered by Asian Development Bank (ADB). I led action-oriented research based on a nationwide survey of 3,500 households in different geo-ecological zones by providing special attention to climatically and geographically challenging (coastal, natural depressions, river islands) regions of the country. The final report dealt an in-depth analysis of the profile of various shocks facing poor, the supply

of public & private health services in the survey areas, the need and demand for microinsurance among the micro-credit borrowers, and the design of prototype insurance schemes (health, life and livestock) for possible pilot testing.

- 3. July 2010 October 2011: Team Leader, Appropriate Micro-insurance Approach for the Ultra Poor in Bangladesh, UNDP funded study at InM, Dhaka, Bangladesh. The scope of this study was similar to the DIISP study cited above but focused on poor destitute women in selected areas of Bangladesh that were covered by UNDP's Rural Employment Opportunities for Public Assets (REOPA) Project at the time with its own dedicated, bur smaller (400 households) primary survey.
- 4. 2005-7: **World Bank Institute Resident Adviser, Bangladesh Bank** (Central Bank of Bangladesh), Dhaka, Bangladesh: Project on Research Capacity Building.

Project/Assignment features/objectives: The goal was to create a new Policy Research Group within the Bangladesh Central Bank from scratch, recruit & train suitable staff & have the group undertake policy research on monetary and financial policy issues.

Activities performed: (i) Sequentially I recruited suitable staff reaching strength of 20-22 members by the end of first 12 months.

- (ii) Design a training program (including formal courses & lectures), locate suitable internationally known experts to offer such training & implement the training with self-participation.
- (iii) Design a research strategy for the overall Unit over each quarter and lead the research work and integrate this with the training program in progress.
- (iii) Ensure timely production of several key documents, namely, a quarterly journal, semiannual reports each on Monetary policy review and financial sector review.
- (iv) Arrange and conduct an active seminar program with international visitors & local experts on matters of interest to the Central bank ensuring full participation from within the Bank as relevant (including the senior management),
- (iv) Communicate the research work, its methods and findings as appropriate in high-level meetings within the Bank, the stakeholders and the financial media/press, frequently briefing the media directly ('press conferences').
- (vi) Regularly reviewed the speeches that the Governor made on policy matters, to whom I was reporting directly for my duties as the WB resident Advisor on this assignment.
- 5. **March-April 2003: Sabbatical Fellow, WIDER** (World Institute of Development Economics Research) UN University, Research on Poverty and Inequality.

Project/Assignment features/objectives: Undertake research on Poverty Reduction.

Activities performed: I have studied mainly the issues of poverty reduction and attainment of millennium development goals (MDGs) in wider institutional economics context for East

European and Former Soviet Union (EEFSU) countries as well as those of the Middle East and North Africa (MENA) region.

6. **Winter 2002: Visiting Scholar, PKSF, Dhaka**, Bangladesh: Work on Poverty Reduction Policy: Macro Perspectives.

Activities performed: I have researched and carried out field level studies on the sustainability of micro finance & it macro implications.

7. **Summer 1999: Visited PKSF, Dhaka,** Bangladesh. Research on the Targeting Poverty Programs for *the Hardcore Poor*.

Project/Assignment features/objectives: Poverty Reduction strategies suitable for the Hardcore Poor.

I supervised research of a group of five students from Hungary (1), Kazakhstan (1), Romania (1) and Ukraine (2) on problems ranging from privatization and employment (Hungary and Kazakhstan), the tax reform (Romania), foreign direct investment (Ukraine) and Banking Reform (Ukraine).
- 11. Summer 1994. Spent one month (June) in Bangladesh on a World Bank study on *Rural Credit and Poverty Alleviation*, the research was completed in March 1995.

Project/Assignment feature: A Comparison of the Efficiency of Major microfinance lenders visà-vis BRDB.

Activities performed: Analysed various reports put out by major MFIs & following personal meeting with senior staff, and prepared a research report, which was presented at an international conference in Dhaka in March 1995.

12. Also in 1994 I was invited by the **International Association of Agricultural Economists** to write a discussion of the *Structural Adjustments in sub-Saharan Africa*, which was presented at a conference in Harare, Zimbabwe in August 1994. A short version of this report has now been published. (See item 12 on p3 of CV).

Wrote a research report on the Structural Adjustments in sub-Saharan Africa with a special focus on agriculture?

13. Winter 1994. Commissioned by the ADB (Manila) to write a paper on *Tax Evasion for Developing Countries* and to serve as an invited speaker in a *Symposium on Tax Reform in the Asia-Pacific Region*. The event was meant to be a training program targeted at senior tax administration officials from 17 Asia-Pacific member countries of ADB.

Wrote a major piece on Tax Evasion from a development perspective and presented this in a workshop in Dhaka.

14. *August 1993:* Visited Delhi University in India to explore the possibility of a collaboration on *Environmental Regulation and Sustainable Development*. The visit was supported by a CIDA-Shastri Foundation grant.

This was to meet scholars based at Delhi University who were actively engaged in research in the field of environmental regulation & what effect that may have on growth potential in a sustainability framework.

15. **April-Sept 1992: Visited Seikei University in Tokyo, Japan** where I carried out research on *Bangladesh Tax Reform*. Results of this project were subsequently published as items 10 and 11 on p3 of the CV.

This was mainly a teaching assignment, but a significant effort was spent in studying the Bangladesh Tax system and explore the scope of serious reforms in order to make it more efficient (smaller dead-weight loss) and offer greater revenue potential.

- 16. Jan 1991-Jan 1993: President, Association of Economic and Development Studies on Bangladesh, (a learned society with offices in Washington, DC), also a member of the Allied Social Science Associations. Organised several conferences on development studies with a focus on South Asia and Bangladesh on behalf of the society.
- 17. **Dec '89-Feb '90. Visited the Bangladesh Institute of Development Studies** and gave lectures to graduate students in an *Advanced Quantitative Economics program*. This was sponsored by the UNDP. Here I basically taught a course on Mathematical Methods in Modem Economic Analysis.
- 18. Winter 1989. Obtained a CIDA grant to organise an *International Workshop on the Flood Problem in Bangladesh*, which was held in May of that year. While CIDA was the principal sponsor, the meetings drew participants and support from the World Bank, IDRC (Canada), US State Department and the External Affairs Ministry (Canada). My own work on this topic has been published as item (9), p3 of CV.

I prepared a Concept Paper for the Workshop, successfully contacted granting agencies, connected with leading academics on the topic from all over the word and managed to successfully hold the 2-day event which many agencies (World Bank, IDRC/CIDA/Govt to Canada, US Dept of State/US AID) as well as individual scholars (leading universities in Canada/US, Europe, Bangladesh & Nepal) participated.

19. Aug'82-June'83. On sabbatical leave, I was appointed the Director, *Rural Economics Project* at Chittagong University, Bangladesh on a joint SSHRC (Canada) & Ford Foundation (Dhaka) sponsorship. Carried out and supervised research on aspects of the rural economy especially *Crop Insurance*. Several publications were realised; see items #1 (p2), and 5 and 6 on p3. Some early research reports were presented in workshops in India (Aug '82), Indonesia (Aug'82), and Singapore (Sept'82).

Activities performed:

- (i) Research on microfinance, rural credit and crop insurance in Bangladesh;
- (ii) Supervise research on microfinance undertaken by the staff of the Rural Economics Project led by Professor M. Yunus; and
- (iii) Prepare research documents for publication and release in the media.
